PRAYER BY REV. ROGER MILLER

COMMUNICATIONS

Dr. Edmundo Garcia, Zapata County Medical Group, reported that they had seen 860 patients in the month of November. Patient numbers are staying steady and more doctors are coming in. (Report attached for the record.)

Judge Guerra announced that there will be a Falcon Zoning workshop on December 15, 2009.

Juan Cantu, Community Action Council, addressed the Commissioners' Court and stated that they would be doing the annual call for proposals. Community Action Council will entertain to submit proposal to TxDot to start route from Zapata to Webb County, LCC, Metro Depot, LCC Fort

McIntosh, work, mall, TAMIU, and Bob Bullock Loop 20 to provide transportation to County residents that have a need to travel. A minimal charge of \$5.00 per round trip will apply to show community participation. Proposals are due December 2009 and funds would become available in July 2010.

Peggy Umphres-Moffet submitted a draft of a resolution for local incentive programs. Resolution is for tax abatement. Ms. Umphres-Moffet requested a date for a workshop for incentive programs. Commissioner Vela suggested that a feasibility study for an international bridge. Ms. Umphres-Moffet stated that there are funds in the Skill Development Fund Program that could be used to assist in the transportation program. Mario and Amada Garza will have the prototype for the pipeline marker on December 16, 2009. There is a possible business prospect (correctional facility) that would create jobs for the community, it would consist mostly of Federal inmates with immigration violations.

Luis Lauro Gonzalez, Zapata County Tax Assessor/Collector, presented Commissioners Court with the October - November report. He reported that the tax office collected \$18,026,722.98 being 79 % collections. (Report attached for the record.)

Romeo Salinas, Zapata County Treasurer, presented Commissioners' Court with a written Treasurer's Report. (Report attached for the record.)

Caleb Eaton, Zapata County Extension Agent, presented Commissioners' Court with a written report and update on the Extension Office. (Report attached for the record.)

ORDER APPROVING HIRING OF TWO BUS DRIVERS AND FUEL TO ROLL OUT CONGRESSMAN CUELLAR EDUCATION PROGRAM
