COMMUNICATIONS

Com. Elizondo stated that the API Roping was a success. The announcing booth was repaired. Com. Vela commended Jose Mendoza for preparing the arena.

Com. Elizondo commented that trash bins were put up in Medina Addition for large household items.

Vickie Vela-Garcia commented that the Farmers and Artisans Market consists of merchants who sell handmade and locally grown items. She is thinking of having a kids cool off and talent show to bring in more people. She would also like to change the venue to the plaza. She asked for a recycling bin to promote recycling. Street vendors have been approached, but are not interested because they park by the road for free.

Ramiro Hernandez reported that the Boys and Girls Club will be preparing 300 meals per day at the Nutrition Center. Supper will be served June 6 - August 19. If inspection passes they will provide meals for the entire school year. The club will hire one additional employee and eight more once the grant is in place. Children ages four to 17 eat on site. The parents are encouraged to stay while the children eat.

Little League starts in two weeks. Participation is down to \$250 from \$400.

Selina-Roxana Davis and Maria Sendejo Davis addressed the Court regarding item #16 on the agenda pertaining to the amendment of Fowl Control Addendum (section 19) of Animal Fowl Ordinance in reference to animal control and the limit of fowl and livestock on personal property. They stated that the complaining neighbor had no problems with the animals until he decided that he wanted to sell his property. They have 3 goats, 4 ducks and chickens. All animals are well kept and contained.

Mr. Saenz responded to the complaints and enforces what is brought to his attention.

Mr. Hector Uribe will refine the ordinance.
