MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Commissioner Vela commended the River Pierce Foundation for the restoration project in San Ygnacio.

Commissioner Elizondo commented that Villarreal Elementary visited A.L. Benavides.

Commissioner Elizondo also stated that there had been a watermelon distribution. Items come from Laredo Food Bank.

Commissioner Vela commended the Little League for hosting a tournament.

Ramiro Hernandez stated that several teams from Laredo, Rio Grande and Zapata participated.

Mr. Hernandez also gave an update on the Boys and Girls Club. Approximately 100 kids are participating every day. There is a back pack program in progress. The club applied for the USDA grant. They are serving 100 meals a day.

He further stated that he runs the club like a military operation. He is looking into expanding to include meals for all age groups instead of just school age. A contractor will be doing the kitchen renovation and one of the air conditioners will be replaced.

He also informed the Court that a pump went out in the swimming pool, it was not cycling the water. He will make a phone call today about having it repaired.

REPORT BY LNV REPRESENTATIVES TO INFORM THE COURT ON POSSIBLE PROFESSIONAL CONSULTING SERVICES AVAILABLE

Enrique Valdez and James Ornelas, PE, representatives of LNV informed the court on possible professional consulting services available for those counties meeting eligibility for federal and state grants. LVN headquarters is located in Corpus Christi, they provide presentations and work with the Texas Department of Agriculture. They look for Texas Water Development Board Loans at 6.5% interest rate and work with the Department of Energy. They do free audits and advise on how to conserve energy. They will look into Texas Water Development Board grants to replace water meters. Commissioner Vela will place Mr. Ornelas on the agenda to give a presentation at the Tax Appraisal District.

ORDER TO PROCEED WITH PURCHASE AND INSTALLATION OF A CALL MANAGER SYSTEM FOR ZAPATA COUNTY SHERIFF'S OFFICE, ZAPATA COUNTY REGIONAL JAIL AND ZAPATA COUNTY WATERWORKS

Motion was made by Commissioner Vela, seconded by Commissioner Garza, to approve to proceed with the purchase and installation of a Call Manager System for the Zapata Co. Sheriff's Office, Zapata Co. Regional Jail, and Zapata Co. Waterworks. Existing lines will be merged and changed to fiber optic with Time Warner at a cost of \$24,000 from new budget and will take from 90 to 120 days to occur. Phone numbers will remain the same as requested by Honorable Joseph Rathmell, County Judge.
