MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT INVOCATION BY PASTOR ROGER MILLER, COMMISSIONERS COURT **CHAPLAIN** PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Brian Martinez thanked the Court for the 7 years of service. He also stated that on behalf of Zamorales, he would like to request the use of the Community Center the last week of November for the Zamorales Annual fund raiser.

Commissioner Elizondo stated that she is organizing a Fall Halloween Festival for the community. Spaces are \$20 and the money is going to the Christmas fund and for a dinner for the elderly.

Judge Rathmell commented that we got 4-1/2" of much needed rain. Commissioner Garza added that the County may need to obtain easements for arroyos in order to be able to clean and maintain them.

Commissioner Elizondo asked Joyce Currington, of the Zapata County News, to publish that the trash trailer will be at the pavilion on the 2nd and last Friday of the month.

ORDER APPROVING INVOICES

Motion was made by Commissioner Martinez, seconded by Commissioner Garza, to approve invoices as presented by Triunfo Gonzalez.

PRESENTATION ON USDA HOME LOAN PROGRAM

Eric Haner, USDA Housing Specialist, made a presentation on USDA Home Loan Program for very low, low and moderate income households. There is 100% financing at 2.875% interest on 33-38 year loans. Income limits apply, however, if an applicant goes over the limit there are other options available. They come to Zapata on the last Thursday of every month. They also offer assistance for tap fees for water and sewage connections.

ORDER APPROVING FUNDING FOR INSTALLATION OF PHONE LINES AT SHERIFF'S DEPARTMENT TO TRANSITION TO TIME WARNER COMMUNICATIONS FROM AT&T

Meza, Fire Chief.

ORDER APPROVING ADDITIONAL FUNDING FOR ZAPATA COUNTY CHAMBER OF COMMERCE FROM HOTEL MOTEL TAX FUND FOR 2017 TEXAS B.A.S.S. NATION CHAMPIONSHIP FISHING TOURNAMENT

Motion was made by Commissioner Martinez, seconded by Commissioner Garza, to approve additional funding for the Zapata County Chamber of Commerce in the amount of \$9,500.00 from the Hotel Motel Tax Fund from fiscal year 2015-2016 funds, for the 2017 Texas B.A.S.S. Nation Championship Fishing Tournament. Tournament will take place on February 16-18, 2017 and is projected to bring in an estimated 225 adult anglers and \$157,000.00 in revenue to the community of Zapata as requested by Paco Mendoza, Zapata Co. Chamber of Commerce.
