MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF COMMISSIONER S COUT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

ORDER APPROVING PROCLAMATION HONORING JORGE AND EDNA MONTES ON 70 YEARS OF MARRIAGE

Motion was made by Commissioner Mendoza, seconded by Commissioner Solis, to approve proclamation honoring Jorge & Edna Montes on 70 years of marriage as requested by Hon. Joe Rathmell, County Judge.
