THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT COMPRISES APPROXIMATELY 248 ACRES AND IS LOCATED EAST OF HIGHWAY 83 IN NORTHERN ZAPATA COUNTY JUST BELOW THE WEBB COUNTY LINE.
