

## 2014 Property Tax Rates in Zapata County

This notice concerns 2014 property tax rates for Zapata County. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

## Statement of Increase/Decrease

If Zapata County adopts a 2014 tax rate equal to the effective tax rate of 0.722100 per \$100 of value, taxes would decrease compared to 2013 taxes by \$ 37,263.

## Schedule D - State Criminal Justice Mandate (For Counties)

Zapata County County Sheriff has provided information on these costs, minus the state revenues received for reimbursement of such costs.

## Schedule F - Enhanced Indigent Health Care Expenditures

The Zapata County spent \$ 0 from October 1, 2013 to September 30, 2014 on enhanced indigent health care at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is 0.
