## MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER PLEDGE OF ALLEGIANCE

#### COMMUNICATIONS

Judge Rathmell reported on the COVID-19 testing results as follows: there are currently 18 active cases, 340 have tested positive, 1 pending, 320 have been released from isolation and 7 deaths.

Chief Meza advised that there will be testing on October 13 - 15, from 9 a.m. to 4 p.m. at the community center, the test will be performed as an oral swab.

Commissioner Mendoza noted that early voting has started.

Mary Jayne Villarreal-Bonoan, County Clerk added, that early voting will also be conducted on Saturday, October 17 and Saturday, October 24.

Commissioner Mendoza added that the Census deadline has been extended to October 31; Zapata County only shows 24.7% participation.

Judge Rathmell and Commissioner Elizondo commented on the decorations at the County Plaza.

# **ORDER APPROVING INVOICES**

Motion was made by Commissioner Mendoza, seconded by Commissioner Garza, to approve invoices in the amount of \$524,671.76 as presented by Triunfo Gonzalez.

#### TAX / ASSESSOR COLLECTOR'S REPORT – not present report submitted

Tax Assessor/Collector's office reported Hotel-Motel tax collections in the amount of \$3,973.32 for the month of September with a year–to-date total of \$94,198.33. Tax collections at a rate of 89.10%.

#### UPDATE ON CHILDREN'S ADVOCACY CENTERS SATELLITE OFFICE

Ed Rodriguez of the Children's Advocacy Center was present for Severita Sanchez. He reported that 160 therapy sessions were conducted for a total of 10 children. They are currently doing telehelp visits due to COVID-19. All children were able to continue with assistance.

## ORDER APPROVING MEASURES TO ADDRESS SURGE IN LOCAL COVID-19 CASES

Motion was made by Commissioner Mendoza, seconded by Commissioner Elizondo, to approve measures to address surge in local COVID-19 cases. Curfew is lifted, however, school curfew remains in place; business occupancy 70%; private venues can open at 75%; softball field can open; library can open depending on recommendation of Chief Meza, which is to wear masks and continue with social distancing, as requested by Hon. Joe Rathmell, County Judge.

# ORDER REAPPOINTING COMMISSIONER GARZA AS MEMBER TO ZAPATA COUNTY APPRAISAL DISTRICT BOARD

They have been giving books to kids as well as craft activities. An emergency plan is in place. The San Ygnacio facility has been vacated. They participated in the back-pack program via the Guadalupe and Lilia Martinez foundation. Kids Café snacks/meals are being provided; once school reopens school will provide lunch and the Boys and Girls Club will continue providing snacks and dinner.
