MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY CELICA A. RODRIGUEZ, CHIEF DEPUTY COUNTY CLERK AND PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Judge Rathmell commented that they had a successful trip to Austin a few weeks ago. The county had applied for TPWL grants and they were approved. Projects will include a park in Precinct 2 at 20th and Mira Flores, Los Ebanos Golf Course. The county will move forward with the purchase and some enhancements, including a 22-acre tract to expand land for the county. They are still working on the purchase price and other details.

Gov. Abbot is very frustrated with the ongoing border security crisis and has declared 34 counties to be disaster areas throughout the Rio Grande Border. He is requesting cooperation form county governments to support the effort by issuing local disaster declarations. Zapata County has issued a disaster declaration as of Friday, which will be taken on by the court and it will allow us the ability to access federal and state funds. Gov. Abbot has allocated a billion dollars for border security from the Texas State Budget. The declaration is only effective for 7 days; however, the court may extend it for a longer period to participate in funding. We have seen the numbers in stash houses and other crimes.

Sheriff Del Bosque reported 179 apprehensions, 6 weapons, and assisted in apprehending 1600 rounds of 50 caliber rounds in the San Ygnacio area.

Commissioner Elizondo stated that the Hwy 16 expansion project is something Zapata really needs due to high-speed chases and its only one-way traffic with nowhere to go. Judge Rathmell added that he was told by the district engineer that said project should be bid out in the future. The county has requested surplus materials. The local TxDot yard will remain open; however, employees will have to clock-in in Starr County.

Fire Chief Daniel Arriaga reported that we lost Jose Alejandro, area coordinator with TDEM who passed away on June 5. Covid-19 testing is held Wednesdays and Thursdays. Vaccinations at Fire Department are taking place Monday through Friday 9:00 a.m. -3:00 p.m. still getting a lot of first doses.
