Pfizer vaccines by CVS Monday – Friday 9 a.m. to 7 p.m. and Saturday and Sunday 11 a.m. – 5 p.m. 1<sup>st</sup>, 2<sup>nd</sup> and booster doses.

National Guard is still available on Tuesdays from 12 p.m. to 7 p.m. both Moderna and Pfizer are available.

DHS administers vaccines Monday – Friday 9 a.m. to 3 p.m. Moderna and Pfizer. Daniel's Pharmacy Wednesday, Thursday, Friday 10 a.m. to 5 p.m.

Fire Department is testing at Community Center Tuesday and Thursday 9 a.m. to 3 p.m. Gateway Clinic and Daniel's Pharmacy tests need to make appointments.
