MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Fire Chief Daniel D. Arriaga reported that Covid-19 numbers have dropped significantly; on October 20 FDA amended use for Moderna and Johnson & Johnson booster. Moderna booster has been approved for those 18 and over 6 months after 2nd dose; additional 3rd Moderna dose 28 days after 2nd dose only for severely immunocompromised, such as, persons with HIV and undergoing cancer treatment, not past cancer treatment. Pfizer is the same as Moderna. Johnson & Johnson booster is approved 2 months after initial dose. Mix and match is also approved for immune compromised (mostly cancer patients). Vaccines and testing will take place at community center. Vaccines at community center Monday, Wednesday, and Friday. National Guard will continue testing on Tuesdays. DHS offer both Moderna and Pfizer. Daniel's Pharmacy only Moderna. Information will be posted on Fire Department Facebook page.

Sheriff Ray Del Bosque met with Governor Abbot to discuss the preparation to secure our lake and our border. There will be resources coming in as of today, DPS and other state and federal agencies. They will be preparing for any kind of surge through low lake areas and will be contacting land owners that have adjacent properties with the lake. There have been more activities in the last few weeks. Heavy equipment needs to be stored, some will be at the airport and shooting range. They will be setting up camps in different areas to have a 24/7 watch and they will also be staying at some of the local hotels, as well as, adjoining counties. The deployment will depend on where the surge is occurring. Sheriff Del Bosque will meet with Carl Esser to submit grant application. They are looking at Zapata County for deployment of processing center; that will be discussed with the judge at a later date as processing centers are looking at being closer to the border.

Commissioner Elizondo commented that the Miss Falcon Lake Pageant took place, congratulated the participants, two of which will represent Zapata County.
