# MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT PLEDGE OF ALLEGIANCE INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN

### **COMMUNICATIONS**

Judge Rathmell communicated that we had the honor of having Ms. Xotchitl Torres Small, who serves undersecretary rural agriculture for rural development at United States Department of Agriculture, visit our county. She is the first in a very long time; she was accompanied by Congressman Cuellar and Roel Gomez, for Rural Development, and his supervisor Michael Canales. They discussed various funding opportunities that will be coming our way with the infrastructure plan that was approved in Ccongress. They are stressing broad band and high-speed internet to rural communities. Ms. Torres-Small is very receptive to our needs, enhancing our need for medical providers in our area and paid a visit to the Gateway Clinic. Need for good quality water availability was also addressed. Congressman Cuellar did discuss the possibility of dredging Falcon Lake as we move forward as part of the infrastructure plan. She visited Siesta Shores Water District and noted how they are also trying to improve their water plant and was also proactive as to how this funding could be obtained to help them. This bill will allow rural areas to have grant writing applications. Although, the main topic was broad band, the need for FSA (Farmers Service Agency) for farmers and ranchers was also discussed and the need of more staffing to those agencies. Zapata County lost the local office and requested that the local office be brought back to our community, so farmers and ranchers don't have to travel to central offices that are also understaffed and overwhelmed. EMS and Sheriff's Department were also addressed and the need for both departments to better communicate and the trouble we are currently having with the communication towers, funding is coming this way to assist with these issues. Also stressed was the interconnection of water system throughout our county and throughout the state, not necessarily the rush to regionalize us into one, but the ability to be interconnected with Siesta Shores, there is a beneficial aspect to being interconnected. Home remodeling for seniors is another program that rural development brings. and there will be funding opportunities for our locals. The meeting was a very productive.

Ryan Guillen will be our new Stare Representative.

Danny Arriaga, Fire Chief, reported on Covid-19 as follows:

Vaccines: 1<sup>st</sup> dose – 6 2<sup>nd</sup> dose – 8 3<sup>rd</sup> dose – 3 Booster 224 Overall total Moderna Vaccines 3,189

54 Covid tests were done by the Fire Department.

TDEM informed that they will no longer provide the rapid test kits. DHS will take over testing. Daniel's Pharmacy and Gateway Clinic are still, but have to call for availability. The tests that the county has are expired and cannot be used.

Pfizer has been approved for 5-11 age group; a school drive will be held. PPA clinic and CVS are vaccinating. Appointments can be booked, but walk-ins are also being taken.

Fire Department will continue to vaccinate Monday, Wednesday, and Friday at the community center.

Fire Chief Arriaga also reminded that if anyone needs to be vaccinated at home to reach out and they will go to the home.

Sheriff Del Bosque reported the tower will be disconnected for approximately 2-4 hours for maintenance. MOU's will be necessary to reconnect, they will be reevaluated to see if various entities/agencies still need access. Tower equipment is obsolete and Stone Garden and Lonestar funds will be used for upgrades and repairs.

Joe Pena added that the 911 system is being improved and will soon have virtual 911 callers and will also have texting capabilities.

A significant number of soldiers and law enforcement is present in our county and will be a good economic period for our community. Zapata County has an agreement to allow National Guard to use county property.

Sheriff's Office is reaching out to local ranchers to allow access to property to soldiers and/or law enforcement.

Judge Rathmell commented that two counties are already processing trespassing cases. Grant funding (Operation Lone Star) has been approved, but is still pending particulars.

Commissioner Elizondo stated that USDA will be in San Ygnacio to teach participants how to fill out applications. Volunteers will be at the pavilion.

Judge Rathmell reported on Covid-19 cases as follows: 65+ fully vaccinated - 80.45%  $5+1^{st}$  dose - 70% 5+ fully vaccinated - 61.26%

Active cases - 4 Deaths - 45
