MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Judge Rathmell commented that Fire Chief is at a meeting this morning, therefore, he sent a report on vaccines. He reported that 97 Moderna vaccines were administered; 8 - 1st dose, 11-2nd dose, and 78 boosters were administered by Fire Department. Curative is testing at the community center, EZ Testing is at the Lions Club, and Innovative Laboratories is testing in San Ygnacio. CVS is testing and have the Pfizer vaccine. National Guard is at community center on Sundays only. DHS offers both Moderna and Pfizer. Daniel's Pharmacy and PPA clinic are also administering vaccines.

Covid-19 test results 121 positives 1124 probable cases 2 more deaths for a total of 49

Judge Rathmell added that early voting started today.

ORDER TO TABLE REQUEST BY JUDGE RATHMELL TO CONSIDER AMENDING 2021-2022 BUDGET FOR COUNTY COURT STAFF AND POTENTIAL NEW GRANT FUNDED POSITIONS CONTINGENT WITH APPROVAL OF FUNDING FROM OFFICE OF GOVERNOR OPERATION LONE STARE GRANT

Motion was made by Commissioner Garza, seconded by Commissioner Solis, to table request by Judge Rathmell to consider amending the 2021-2022 budget for County Court staff salaries and potential new grant funded positions, contingent on the approval of funding from the Office of the Governor Operation Lone Star Grant Number 43726011 as requested by Hon. ORDER APPROVING AGREEMENTS FOR MIRAFLORES PARK AND LOS EBANOS GOLF COURSE
