MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Fire Chief Danny Arriaga reported that Fire Department administered 4 Moderna vaccines between February 28 and March $28 - 2 - 2^{nd}$ dose and $2 - 3^{rd}$ dose.

A total of 4,836 tests have been conducted. Curative is still testing, and vaccines are still available.

Judge Rathmell reported on Covid-19 test results as follows: 2,388 total positive tests 6 positives 53 deaths 1,281 probables age 5+ 65.02% fully vaccinated age 65 + 82.05% fully vaccinated

Karran Westerman announced that the JROTC will be having their military ball on April 1 at county pavilion.

Commissioner Elizondo reported that Marion Varela, former jazz player, performed in San Ygnacio.

Judge Rathmell commented that the County Fair auction was very successful. Grand Champion steer did very well.

Jimmy Gonzalez with Linebarger informed the court that there is a Texas grant program available under the American Recovery Plan for people that cannot afford property taxes or mortgage payments due to pandemic. There is a limited pool. Tax office has station available for applications.

Tax Assessor/Collector's office reported Hotel-Motel tax collections in the amount of \$9,728.55 for the month of April with a year-to-date total of \$73,256.13. Tax collections were \$1,129,474.59 with a rate of 84.39%.

ORDER RECOGNIZING AND PROCLAIMING APRIL AS AUTISM AWARENESS MONTH

Motion was made by Commissioner Garza, seconded by Commissioner Mendoza, to approve to recognize and proclaim April as Autism Awareness Month and approve the temporary closure of US Hwy 83 on April 2, 2022, for the Zapata County 6th Annual Autism Awareness K-Run/Walk as requested by Nellie R. Trevino, HR Director.

PRESENTATION BY TXDOT ON ZAPATA COUNTY PROJECTS

Presentation was made by Francisco Cantu, Freddy Lopez, and Danny Flores of TxDOT on various U.S. Hwy 83 Zapata Projects. One of the main scopes is to construct a 4-lane divided highway for an approximate length of 22.45 miles. They are currently working on erosion in the San Ygnacio area. Judge Rathmell commented that Zapata County projects are being pushed back. (Report attached for the record.)

UPDATE ON ZAPATA COUNTY SURPLUS AUCTION

Judge Rathmell reported that approximately \$69,912.90 were generated from mostly heavy equipment auction sales held by C.M. Company Auctions.
