WHEREUPON, the following Orders and Proceedings were had by said Court, to-wit:

MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Judge Rathmell commented that this meeting is taking place today instead of the normal Monday meeting because the Judge and Commissioners will be attending their annual meeting.

Judge Rathmell stated that the last few weeks have been very busy with the rainstorm that occurred almost 3 weeks ago. Some precincts were affected with flooding with water up to 13'. He commended the first responders and volunteers who came forward and assisted with water rescues.

Approximately 20 homes were severely damaged, one manufactured home was swept away and many vehicles were lost.

Rain was beneficial to farmers and ranchers. Falcon Lake came up about two feet. The damages will not be covered by FEMA due to a high threshold. Those that were affected were housed at hotels because county buildings were being used for the ongoing election.

Commissioner Garza added that there were no fatalities, however, nurse Jeannie Granger Cooper, who was also a volunteer was available and assisted an injured person.

Commissioner Elizondo commented that the grapple trucks are in and Commissioners need to decide who is getting the equipment. Commissioner Garza will get the old grappler and remaining commissioners will draw to see who gets the two new grapplers. One grappler is being repaired. Commissioner Garza will share the old grappler with the other commissioner precincts.

Judge Rathmell reported on Covid-19, as follows: No new Covid-19 cases were reported. Home test results are not being reported. 3 probable cases.

ORDER APPROVING INVOICES

Motion was made by Commissioner Solis, seconded by Commissioner Garza, to approve invoices from May 20 – June 9, 2022, in the amount of \$1,456,296.96, including additional invoice in the amount of \$4,658.47 for grapple trucks as presented by Triunfo Gonzalez.

TAX / ASSESSOR COLLECTOR'S REPORT

Tax Assessor/Collector's office reported Hotel-Motel tax collections in the amount of \$16,934.04 for the month of May with a year-to-date total of \$108,543.20. Net tax collections were \$189,386.44 with a rate of 88.35%.

Mrs. Mendoza reported on the Texas Home Owners Fund which was established through the American Rescue Plan. Eighty-seven applications have been submitted, 37 have been approved and some have been denied. Taxes from 2016 have to be paid in order to qualify. A total of \$82,856.84 were paid through May; \$41,303.98 have been paid in June for a total of \$123,873.82

FIRE HYDRANT REPORT BY RALPH TREVIÑO

Ralph Treviño, Water Plant Director, reported on the Fire Hydrants. Fire Hydrants have been inspected; there are a total of 213 in Zapata and 21 in San Ygnacio all are in working order, except for 5 that have faulty parts and will be repaired as soon as parts are received. Report attached for the record.

ORDER APPROVING PAYMENT TO OSO BLANCO LODGE FOR PROVIDING SHELTER TO FLOOD VICTIMS

STATUS REPORT ON FALCON MESA PAVING PROJECT AND APPROVAL OF INVOICES

Motion was made by Commissioner Mendoza, seconded by Commissioner Garza, to approve payment in the amount of \$22,000.00 to Premier Engineering as requested by Manuel Gonzalez, Premier Engineering. Mr. Gonzalez reported that paving plans are ready. Easements are being identified and will try to acquire lands that are undeveloped and are in drainage ways. Lands may be designated as park area. No report was submitted for the record.

STATUS REVIEW ON COLONIA DRAINAGE PROJECT

Mr. Manuel Gonzalez of Premier Engineering gave a status review on the Colonia Drainage Project. He is working with Grant Works on getting a standard form for easement acquisition, and because the county is getting funding a particular language needs to be included. Some property owners have been approached and they are willing to work with the county to donate easements for the drainage improvement. There is an existing 15" sewer line on 6th Street. Project will go 1 block North of Hwy 16 and 4 blocks South of Hwy 16 which is the last block on Costa Rica Subdivision. Border Region has cleared a section of property. Only the bottom of the drainage project will be concrete to keep vegetation from growing. Some of the willow trees will be saved. No report was submitted for the record.

Commissioner Mendoza stated that he put in a request with TxDOT and they will be here today cleaning the sidewalks on Hwy 16 due to residual debris from heavy rains.
