# MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EX-OFFICIO CLERK OF THE COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

#### **COMMUNICATIONS**

Judge Rathmell stated that he and the commissioners attended their annual conference and completed the required hours.

He added that the lake levels have dropped due to the drought and the waterworks is having problems with the water pumps. Monterrey, Nuevo Leon is also in dire straits due to the limited water supply. The county is trying to improve the system by possibly recycling the water.

Judge Rathmell reported on Covid-19 results:

2,2455 total positive cases with an increase of 5 confirmed positive

11 probable cases

No deaths

Numbers may be higher than reflected due to home testing not being reported to the state. Vaccinations are still on going.

## ACTIVE PURE AIR PURIFICATION SYSTEM PRESENTATION BY DAVID VASOUEZ

Mr. David Vasquez, sales representative, with Del Valle Solution gave a presentation on the Active Pure Air Purification System. Left information at Judge's Office. No literature left for the record.

### UPDATE BY DR. SEVERITA SANCHEZ ON CHILDREN'S ADVOCACY CENTER OF LAREDO

Dr. Severita Sanchez, Executive Director of the Children's Advocacy Center of Laredo, updated the court on the services provided to Zapata County by the Children's Advocacy Center of Laredo. Dr. Sanchez thanked the court and stated that the program has been in Zapata County for three years and they are in Zapata 2 days out of the week. They received a grant and have equipment and are now able to do forensic interviews. There is one forensic interviewer assigned to Zapata and will be here as needed. They are here to provide justice for children.

# TO PROVIDE A RESPONSE TO A QUESTION POSED TO THE COURT DURING THE PUBLIC COMMENT SECTION ON JUNE 10, 2022 AS TO WHETHER THE COUNTY SHOULD CONSIDER THE ZAPATA COUNTY CHAMBER OF COMMERCE AN AGENCY OF THE COUNTY AS REQUESTED BY HON. JOE RATHMELL, COUNTY JUDGE

The question was forwarded to the Zapata County attorney. Council reviewed the question and responded that the Chamber of Commerce is not considered an agency, but would have an agency like association with the county specifically if the county provides funds to the entity in amounts sufficient for operation or a substantial amount, then they are an extension of the county. The chamber's function is to promote Zapata County, based on that they would not be an agency and cannot act on behalf of Zapata County but is an agency type of relationship when are acting on behalf of Zapata County to promote the county. Because there have been attorney general opinions when the governmental funds are transferred over there is an expectation that the chamber will perform that government function on behalf of Zapata County. Because they are doing that, they are subsequently open to the same public records record requests that Zapata County would be. That would be specific to monies that are allocated to the chamber.

Sara Rathmell stated that according to tax code for hotel occupancy tax funds should have had a separate account so each expenditure according to law is supposed to be tracked by the public and by the court. If there is not separate account and funds have been comingled, how do we

separate what was used for the different items County Attorney responded that if monies have been comingled then the entirety of all accounts become public record.
