MEETING CALLED TO ORDER AT 9:00 A.M. ROLL CALL BY MARY JAYNE VILLARREAL-BONOAN, COUNTY CLERK AND EXOFFICIO CLERK OF COMMISSIONERS COURT INVOCATION BY REV. ROGER MILLER, COMMISSIONERS COURT CHAPLAIN PLEDGE OF ALLEGIANCE

COMMUNICATIONS

Commissioner Elizondo thanked everyone for being at Commissioners Court. She will continue working with the community.

Commissioner Garza stated that it was a pleasure working with everyone.

Judge Rathmell commented that we have 2 incoming commissioners. The County Continues moving forward, he is looking forward to working them. He added that the weather is turning colder; Fire Chief Arriaga is putting together a warming center.

Fire Chief Daniel Arriaga stated that the pavilion is being set up and will be on standby. There are 20 cots available as well as 60 blankets.

Water Plant Director Ralph Treviño added that the water plant generators are on standby and staff is ready. We should all know where meters and shut offs are located. He recommended that we leave a constant drip at the farthest faucet.

Fire Chief Daniel Arriaga added that there was an accident at Villarreal Elementary. A mom drove over a child's feet. Air Evac flew the patient out and is now recovering and in stable conditions.

Judge Rathmell commented that 1.M emergency funding for water works will be appropriated. Our county has an increase in Covid-19, flu and strep cases.

Fire Chief Daniel Arriaga stated that the new Moderna vaccine is administered on Wednesdays 9 a.m. – 3 p.m.

Judge Rathmell mentioned that some of the candidates will be sworn in at midnight on December 31.
